Agenda I

Informative Matters

The county reversed \$26,530.18 in maintenance charges to the library for work done this fiscal year. With this and the \$25,705.13 reimbursement received last month for maintenance charges from last fiscal year, the library's maintenance expenses, as listed in budget objects 1400 and 1402, are where they should be.

The director attended the 52nd Institute of the Southern California Association of Law Libraries in Santa Barbara. The theme was AI Unleashed: Practical and Ethical Applications for Legal Libraries. Surveys show that a majority of law practice areas across the United States are using some form of generative artificial intelligence for tasks such as drafting and summarizing legal material, information extraction, e-discovery, and legal research. Presenters agreed that, at the moment, commonly used AI platforms function best when performing defined tasks within a constrained data set, such as summarizing a specific set of documents. The larger the data set and the more complicated the task, such as conducting open-ended research in a relatively unconstrained data set, the more prone AI is to "hallucination." Attendees agreed that, as with prior advances in research technology, educated and careful use is required.

The director will attend the Council of California County Law Librarians' spring meeting and legislative day in Sacramento April 2-3.

Minutes of Meeting

Board of Trustees Orange County Public Law Library

The Board of Trustees of the Orange County Public Law Library met February 20, 2024 at 12:15 p.m. at the law library.

- Present: Sherry Leysen, Esq., Hon. Michele Bell, Hon. William Claster, Hon. Robert A. Knox, Hon. Elizabeth G. Macias, Hon. Glenn Salter, and Brendan Starkey. Yasie Goebel and Manuel Escamilla were also present.
- Absent: Supervisor Vicente F. Sarmiento.

President Knox called the meeting to order at 12:17 p.m.

- Agenda VII <u>Public Comment per Government Code § 54954.3</u>. Agenda item VII was taken out of order. Rualta Jagot addressed the board about perceived mistreatment by library staff.
- Agenda I <u>Discuss Informative Matters</u>. The director discussed developments at the library since the last board meeting.

Agenda IIMinutes of January 16 Meeting. Judge Macias moved that the minutes be
approved. Judge Bell seconded the motion, which passed unanimously.

- Approved 6-0
- Agenda III Consent Calendar. There being no objection, Ms. Leysen, Judge Knox, and Judge Macias were appointed to the Personnel Committee, Ms. Leysen serving as chair; Judge Bell, Judge Claster, and Judge Salter were appointed to the Finance Committee, Judge Bell serving as chair; and summary investment reports from the Local Agency Investment Fund and the Orange County Investment Pool for January were deemed received and filed.
- Agenda IV <u>Mid-Year Budget Review</u>. The director informed the board that the library is in good financial condition, with income outpacing expenditures and expenditures on target for the year. He noted that (1) line 7670 Miscellaneous

Revenue is much higher than budgeted because a reimbursement from the county for maintenance erroneously charged to the library in FY2022-23 was logged there and (2) charges to lines 0206 Retiree Medical and 0319 Unit Employee Insurance are higher than anticipated and staff would investigate.

- Agenda VConsider FY2023-24 CWCAP Charges. Judge Claster moved to approve
payment of \$14,001 to the Countywide Cost Allocation Plan for services by the
Auditor-Controller. Judge Bell seconded the motion, which passed
unanimously.
- Agenda VI <u>Comments from Trustees and Staff</u>. There were no comments from trustees or staff.

The board adjourned at 12:59.

Pooled Money Investment Account Monthly Portfolio Composition ⁽¹⁾ 2/29/24 \$164.3 billion



Consider Directors & Officers Insurance Renewal

In 2022, the board approved a new directors & officers and employment practices liability (EPL) policy with Old Republic Insurance Company, which offered the same coverage with a more competitive rate than the previous provider. Old Republic is offering a renewal of the same coverage for \$4,737, 14% lower than budgeted and 5.24% lower than last year.


