Elder Law

s the baby boomers come of old age, they have created increased demand for products and services for the elderly, including legal products and services, and have also increased their powers as a demographic group.

LAWS FOR ELDERS

In 1982, California enacted the first statute addressing the problem of elder abuse. The last significant legislation was in 2008, significantly increasing remedies for financial abuse by persons who would take advantage of elder dementia. This includes not only beauty queens and African officials who need financial help in smuggling vast sums of money out of their countries, but also greedy relatives who try to influence changes in wills. The standard of proof in such cases is "a preponderance of the evidence." The stakes are high and the law is still being developed. Physical abuse cases require the higher standard of "clear and convincing" proof. SB 558, supported by trial lawyers and opposed by nursing home associations, would change this to the lower standard, but it was stalled this summer in the Assembly Appropriations Committee.

LAWYERS FOR ELDERS

The increase in the life and influence of the elderly has increased work for lawyers handling Trusts & Estates. Some lawyers have branched out into other fields, both related and unrelated. The result has been the relatively

Title 51 - Final Positive Law

itle 51 of the United States Code, National and Commercial Space Programs, signed into public law on December 18, 2010, besides being the first new title addition in 83 years, is a recent example of converting United States Code titles into positive law titles.

The Office of the Law Revision Counsel, an independent office in the United States House of Representatives, is required by 2 U.S.C. §285b (1) to convert one title at a time into positive law. That is, to convert the compilations of enacted federal statutes into a positive law title, where the title itself is enacted as a statute. According to the Office, positive law codification "restates existing law, enacts existing law as a 'positive law' title, improves organization, removes obsolete provisions, and corrects technical errors." (Office of the Law Revision Counsel, n.d.) *

With the enactment of Title 51, there is now one location for national and commercial space programs instead of legislation dispersed among Title 15, Commerce and Trade, Title 42, Public Health and Welfare, and Title 49, Transportation. Title 51 does not modify or provide for any new

new specialty that has become known as Elder Law. Both Elder Law and Trusts & Estates are sections of the Orange County Bar Association which have contributed funds to our library for materials.

programs, but reorganizes the statutes to make it easier to find existing law and to allow for further growth. Title 41, Public Contracts, was signed into public law on January 4, 2011, and is now a positive law title.






CEB's OnLaw database contains the full text of all CEB loose-leaf publications, and most of the Action Guides. The software is

the familiar Folio. Clicking into the database from OCPLL's intranet page (available on all Public Terminals in the Library's computer area) reveals the "Welcome" screen. This is where notices about changes to the database are posted, information about how to perform a search or browse titles, or other pertinent information. On the left of the screen are the OnLaw topics. Each topic expands to show specific CEB publications, each publication can be expanded to a table of contents, to publication chapters, sections, etc.



Publisher restrictions do not allow for downloading with ONE happy exception: CEB drafted forms can be downloaded. You will know the option is available when you see the following at the top of any "form":




OCPLL restrictions do not allow using Save Target As, but we've made it even better for you.

Simply click on the box "To download Word version ...".

This will bring a pop-up window "File Download." Click "Open."

The form will automatically open up in OpenOffice. From there you can edit the document as you wish, print it out, or save it to your flash.

The event is remarkable for a number of reasons, but most striking is this simple fact: For the past 83 years, the United States Code has been limited to 50 titles, but now a new title has been added: Title 51, United States Code, "National and Commercial Space Programs."
